AN ORDINANCE ANNEXING INTO THE CORPORATE LIMITS OF THE VILLAGE OF CHOUDRANT, LOUISIANA. THE FOLLOWING DESCRIBED PROPERTY, TO WIT:

The properties lying within and bounded by a line beginning at the center of Louisiana highway 145 at the South Right of way line of Interstate 20 thence proceeding west for a distance of 600 feet thence North parallel to the centerline of Highway 145 for a distance of 7640 feet more or less to the South right of way line of Emory Road thence East 1200 feet along the said right of way line of Emory Road for a distance of 1200 feet thence South Parallel to Highway 145 for a distance of 7640 feet more or less to the South Right of 7640 feet more or less to the South Right of way line of The Parallel to Highway 145 for a distance of 7640 feet more or less to the South Right of way line of Interstate 20 thence West to point of Beginning less and except those portions included in previous annexations.

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE VILLAGE OF CHOUDRANT, LOUISIANA, IN REGULAR SESSION CONVENED:

Section 1. The following described property is hereby annexed into the corporate limits of the Village of Choudrant, Louisiana, to-wit:

The properties lying within and bounded by a line beginning at the center of Louisiana highway 145 at the South Right of way line of Interstate 20 thence proceeding west for a distance of 600 feet thence North parallel to the centerline of Highway 145 for a distance of 7640 feet more or less to the South right of way line of Emory Road thence East 1200 feet along the said right of way line of Emory Road for a distance of 1200 feet thence South Parallel to Highway 145 for a distance of 7640 feet more or less to the South Right of 7640 feet more or less to the South Right of way line of The Parallel to Highway 145 for a distance of 7640 feet more or less to the South Right of way line of Interstate 20 thence West to point of Beginning less and except those portions included in previous annexations.

Section 2. The property hereby annexed shall be zoned OL, Open Land and be subject to the Village of Choudrant Zoning Regulation Ordinances accordingly.
