ORDINANCE NO. 80

AN **ORDINANCE** TO AMEND AND **REENACT** 55 OF ORDINANCE NO. THE VILLAGE OF CHOUDRANT FIXING THE MAXIMUM SPEED LIMITS AT WHICH MOTOR VEHICLES MAY BE OPERATED UPON CERTAIN STREETS WITHIN THE VILLAGE OF TO PROVIDE PENALTIES FOR THE CHOUDRANT; THEREOF; AND OTHERWISE **VIOLATION** PROVIDE WITH RESPECT THERETO.

NOW, THEREFORE, BE IT ORDAINED, by the Board of Aldermen of the Village of Choudrant, Louisiana, convened in Regular Session this 1st day of August, 2005, that the following Ordinance is hereby enacted:

SECTION 1.

As used hereinafter, the term "motor vehicle" shall mean any self-propelled or motorized apparatus or device in, upon, or by which any person or property is or may be transported, drawn, or pulled upon a highway, road or street, except devices moved by human or muscular power or used exclusively upon stationary rails or tracks.

SECTION 2.

No motor vehicle shall be operated upon the streets of the Village of Choudrant at a rate of speed which exceeds the rate of speed designated hereinafter for each such street.

SECTION 3.

Anyone who violates the provisions of this Ordinance shall be fined not less than FIFTY AND NO 100THS (\$50.00) DOLLARS no more than FIVE HUNDRED AND NO 100THS (\$500.00) DOLLARS, or imprisoned for not more than ten (10) days, or both.

SECTION 4.

If any section, paragraph, sentence, clause and/or phrase of this Ordinance or the application thereof is declared unconstitutional, unenforceable or invalid by the valid judgment of any court of competent jurisdiction such unconstitutionality, unenforceability or invalidity shall not affect any of the remaining sections, paragraphs, sentences, clauses and/or phrases of this Ordinance, since the same would have been enacted by the Village of Choudrant, Louisiana without the incorporation in this Ordinance of any such unconstitutional, unenforceable or invalid section, paragraph, sentence, clause or phrase. To this end, the provisions of this Ordinance are hereby declared severable.

SECTION 5.

All other ordinances, or any parts thereof, which are in conflict with the provisions of this Ordinance are hereby repealed.

SECTION6.

This ordinance shall become effective upon approval of the Mayor.

The above and foregoing Ordinance was introduced by Joe R. Aswell at the regular meeting of the Board of Aldermen of the Village of Choudrant, Louisiana, held on July 11, 2005 who thereafter moved for its adoption. The motion was seconded by Eddie Ford and after having been considered by title was adopted as a whole by the following YEA and NAY vote:
