The following Ordinance was offered by Philip D. Johnson who moved its adoption.

ORDINANCE NO. 56

AN ORDINANCE

Authorizing the Mayor of the <u>Town of Choudrant</u>, Louisiana, hereinafter called "Municipality", to enter into an Agreement with Louisiana Power and Light Company for the supply of electric service for the operation of <u>Streetlighting</u>, water pumping, sewerage pumping and other municipal services of said Municipality for the term provided therein, and to provide for the payment of the amount due under said Agreement.

SECTION 1. BE IT ORDAINED by the Mayor and <u>Town Council</u> of the <u>Town of Choudrant</u>, Louisiana, in lawful session convened, that the Mayor, <u>Bill Sanderson</u>, be and he is hereby authorized, empowered and directed to enter into an Agreement with Louisiana Power and Light Company, its successors and assigns, for supplying the <u>Town of Choudrant</u> with electric power and energy for the operation of <u>street lighting</u>, <u>water pumping</u>, <u>sewerage pumping</u>, and other <u>municipal services</u> in the words and figures as set out in the attached Agreement, copy of which Agreement is made part hereof and considered as incorporated herein.

SECTION 2. BE IT FURTHER ORDAINED, etc., that the Mayor and/or such other officers or persons for and on behalf of the Municipality be and they are hereby authorized and directed to make all payments to become due under said Agreement in accordance with he conditions thereof during the entire term of said Agreement without further action by the Mayor and <u>Town Council</u>.

SECTION 3. BE IT FURTHER ORDAINED, etc., hat this Ordinance being necessary to the public health and safety and public welfare and convenience requiring it, shall take effect from and after the date of its adoption.

SECTION 4. BE IT FURTHER ORDAINED, etc., that all ordinances, actions or parts thereof, in conflict herewith be and the same are hereby repealed, it being the intent of the Mayor and <u>Town Council</u> that this Ordinance and Agreement made part hereof supersede all existing agreements and contracts now in effect which in any way conflict with the matters herein agreed upon.

WHEREUPON, in open session said Ordinance and Agreement were read and considered section by section and as a whole.

Mr. Reagan Aswell seconded the motion to adopt he Ordinance.
